- Celebrate successes and learn from failures – acknowledge achievements and view failures as opportunities for learning and adjust strategies accordingly
- Monitor and maintain the process of Continuous Improvement

### **Liaise with QHSE**

- Supervise the company's QHSE processes and procedures – make sure that appropriate safety and security standards and procedures are developed and implemented
- Be the guarantor of QHSE mechanisms and certificates; maintain and improve compliance with HSE standards
- Be the guarantor for QHSE on behalf of CEO
- Coordinate the QHSE risk analysis process at various project stages
- Manage support from QHSE resources: QHSE coordinator and QHSE operational contact person who will perform audits and ensure safety and security of people and material on site; also coordinate external suppliers in that regard
